EPT 124 Emergency Management Services Law and Ethics

Course Description

This course covers federal and state laws that affect emergency service personnel in the event of a natural disaster or terrorist incident. Topics include initial response and long-term management strategies, with an emphasis on legal and ethical considerations and coordination between local, state, and federal agencies. Upon completion, students should have an understanding of the role of private industry, government agencies, public policies, and federal/state declarations of disasters in emergency situations.

Course Hours Per Week: Class, 3; Lab, 0, Credit: 3

Course Objectives:

- a. Describe and have a basic understanding of US Code Title 42, Chapter 68 Disaster relief, or the Stafford Act and the disaster ordinances, the federal law that covers disaster relief and addresses typical situations and legal implications involved in federal emergencies.
- b. Describe aspects of National Emergency Powers as depicted in the Congressional Research Service (CRS) Report prepared for Congress.
- c. Identify and understand the Ethics of Duty (deontology).
- d. Describe the roles and responsibilities of private industry and the laws that influence private industry in an emergency situation.
- e. Identify significant aspects of Contract Law.
- f. Describe and understand the impact of public policy with regards to incident management.
- g. Define and describe what is considered a "State of Emergency."
- h. Describe the terms, conditions, and legalities of Title 10 (Federalized National Guard).
- i. Identify legal issues and procedures involved in mandatory and non-mandatory evacuations.
- j. Develop an understanding of Environmental Law as it relates to incident management.
- k. Identify factors and implications of municipal, county, state, and federal/tribal laws on incident management.
